RULES & REGULATIONS

OBJECTIVE

The objective of this Tournament is to foster and promote goodwill, friendship and sportsmanship amongst the youth bowling fraternity.

ORGANIZATION AND SANCTION

The Ampang Superbowl Junior Classic 2022 is organized by Ampang Superbowl and sanctioned by Malaysian Tenpin Bowling Congress.

ELIGIBILITY

All current MTBC members of good standing bowlers accredited by their respective Association aged 21 years and below (born year 2001 and after) are eligible to participate in this tournament. Current bowlers in the National Youth Program are not allowed to participate.

STANDARD OPERATING PROCEDURE (SOP)

- Tournament standard operating procedure shall apply.
- All participants must be fully vaccinated.
- 12 and under participants have to be accompanied by only ONE guardian or parent.
- All bowlers must fill in 2 required forms and attach with their digital certificate. All bowlers must do RTK saliva test in the bowling centre before starting their first event. Bowlers have to report one hour earlier for their first event. The test cost is at RM16.00 per person. Payment for RTK saliva will be made by the bowler themselves. Any bowler found positive will not be allowed to participate in this tournament and will not be allowed entry into the premises.
- Entry of parent or guardian will be based on number of the capacity in the bowling centre. The organizer reserves the right to reject any entry once the capacity allowed is full. The bowling centre has to be vacated during oiling and sanitization procedures.

AVERAGES

All grading will be based on the official averages of MTBC (74) and bowler without established average must produce written confirmation of their averages from their respective Associations.

CATEGORIES

- Boys Open averaging 191 and above.
- Girls Open averaging 181 and above.
- Boys Graded averaging 190 and below.
- Girls Graded averaging 180 and below.
- Boys & Girls U12 born in 2010 and after.

All entries must be submitted with the relevant fees. No refund will be allowed.

- Master Final RM 150.00 per bowler.

HANDICAP

Handicap will be given to the following categories (per game):

- Boys Open 0
- Girls Open 5 pins
- Boys Graded 5 pins
- Girls Graded 8 pins
- Boys U12 8 pins
- Girls U12 12 pins

* handicap will be given during Qualifying and Master Final.

FORMAT

Each bowler will bowl 16 games in the qualifying round, divided over two (2) blocks of eight (8) games each. Top 30 bowlers with the highest total pinfalls including handicap from the qualifying stage will proceed to the Master Final.

Master Finalist will bowl 10 games and the bowler with the highest total pinfalls including handicap will be declared the winner.

All finalists are required to register personally at the registration counter. Failing to do so, reserves will be called 15 minutes before the game starts.

OILING PATTERNS

Oiling patterns will be decided by the Tournament Management and will be posted one (1) week before the date of the tournament.

LANE ASSIGNMENT AND CHANGE OF LANES

The manner and number of lane changes will be announced at the start of each squad by the Tournament Director. The lanes of which the bowler shall bowl will be assigned by the Tournament Management.

TIE-BREAKING PROCEDURE

In the event of a tie for the last position in the qualifying round, the highest last game (excluding handicap) will decide. If the last game is still a tie, the 2nd last game (excluding handicap) will decide. This will continue until the tie is broken.

If a tie occurs in a position after the Master Final, the bowler with the highest last game (excluding handicap) will be declared the winner. If the last game is still a tie, the 2nd last game (excluding handicap) will decide. This will continue until the tie is broken.

REGISTRATION OF BOWLING BALL

It is the bowlers' responsibility to ensure that all bowling balls used during the Tournament are verified for correctness of weight and other specifications. If in doubt, the ball may be verified by the Tournament Technical Committee. The Tournament Technical Committee reserves the right to recall any ball(s) for inspection at any time.

VERIFICATIONS OF SCORES

It is the bowlers' responsibility to ensure that the correct score for each game is recorded in the official score sheet by signing on the official score sheet.

BOWLERS ATTIRE

Bowlers are requested to be dressed for their events with a sense of decorum.

SLOW BOWLING

The Tournament Management views the 'Slow Bowling' infringement as serious as this would disrupt the tournament schedule.

Bowlers shall be warned by the Tournament Director by way of white, yellow and red cards. Bowlers shall be penalized when shown the red card whereby penalty of zero for the frame being bowled.

PROTEST

- Scores Must be submitted in writing to the Tournament Directors or their Assistants within 12 hours of the event. No protest made after the prize presentation will be entertained.
- Eligibility Must be submitted in writing to the Tournament Directors or their Assistants within 12 hours of the first infringement.
- Foul Must be brought to the attention of the Referee before the delivery of the next ball. No complaint made after the 2nd ball has been bowled shall be entertained.

SPECIAL NOTES

The Tournament Directors, or, in his absence, his appointed official on duty, reserves the right to accept or reject any entry as deem fit. Any matters arising which are not covered in these Rules and Regulations will be decided by the Tournament Directors. The decision of the Tournament Directors shall be final. Such appeal should be made in writing and within 12 hours of the decision by any of the above.
